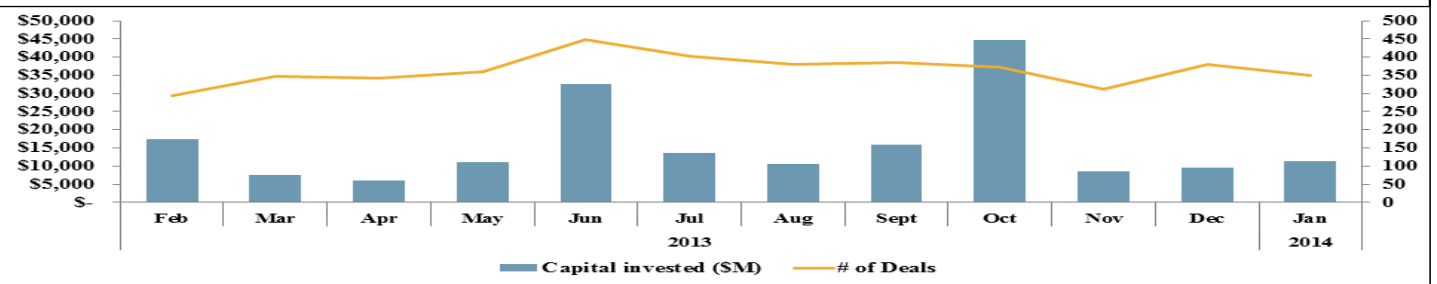

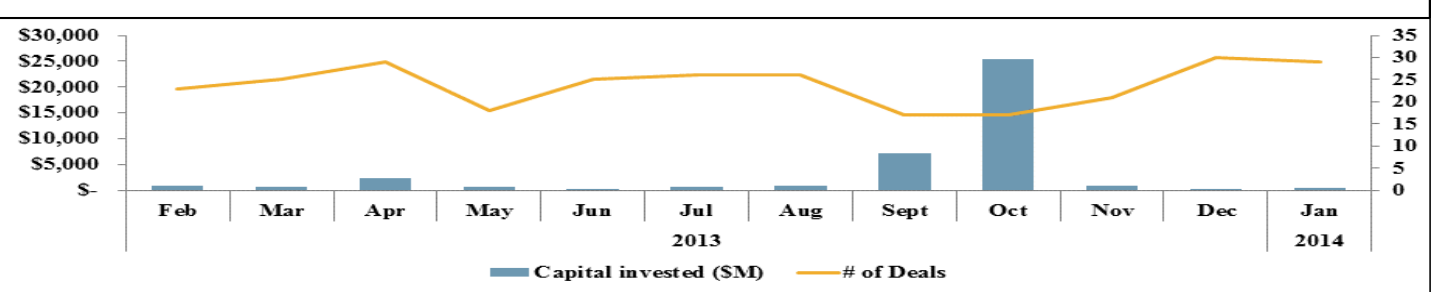

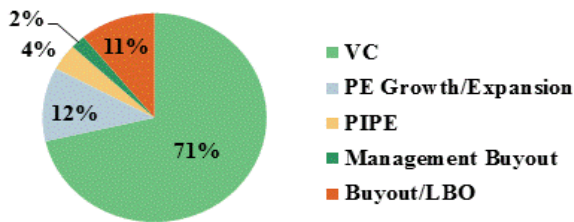
Completed PE & VC Deals in US (LTM)



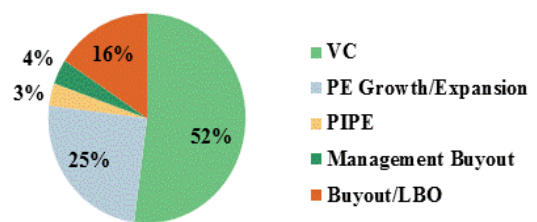
Completed PE & VC Deals in TX (LTM)



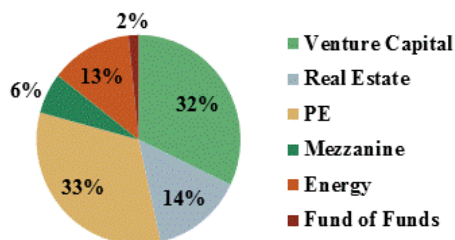
US Deals by Type



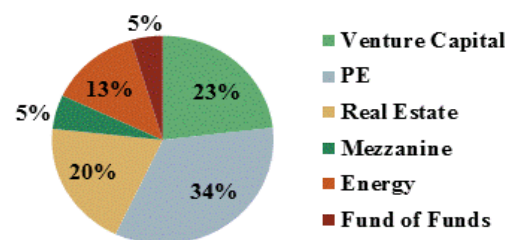
Texas Deals by Type

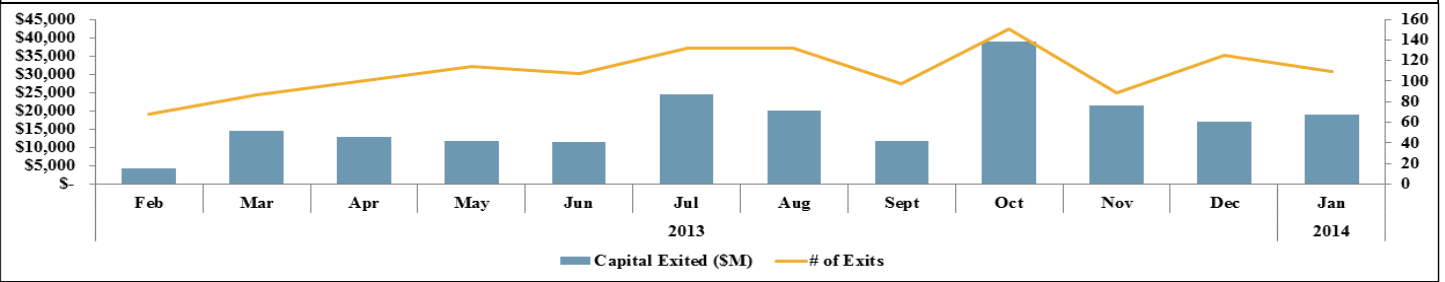

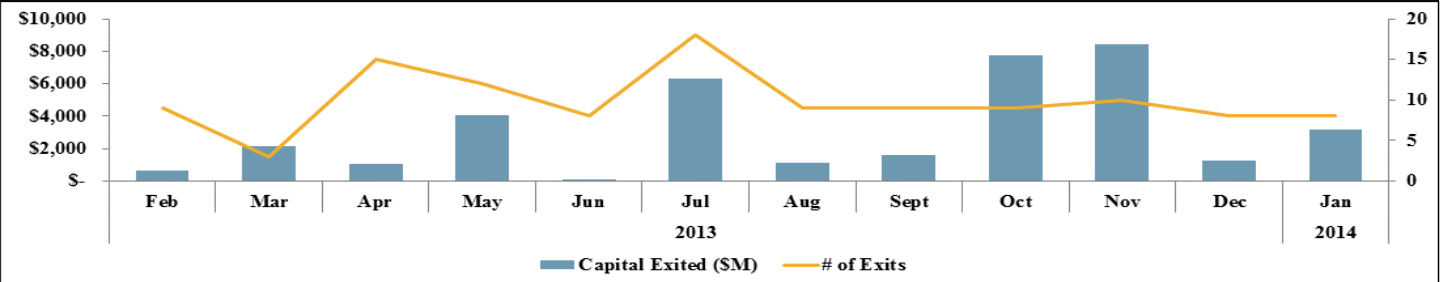

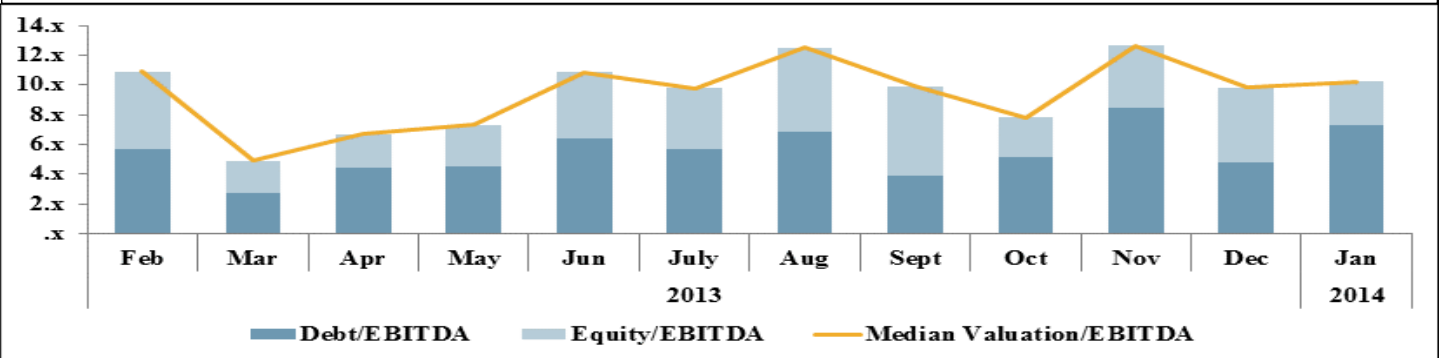
Exited PE & VC Deals in US (LTM)



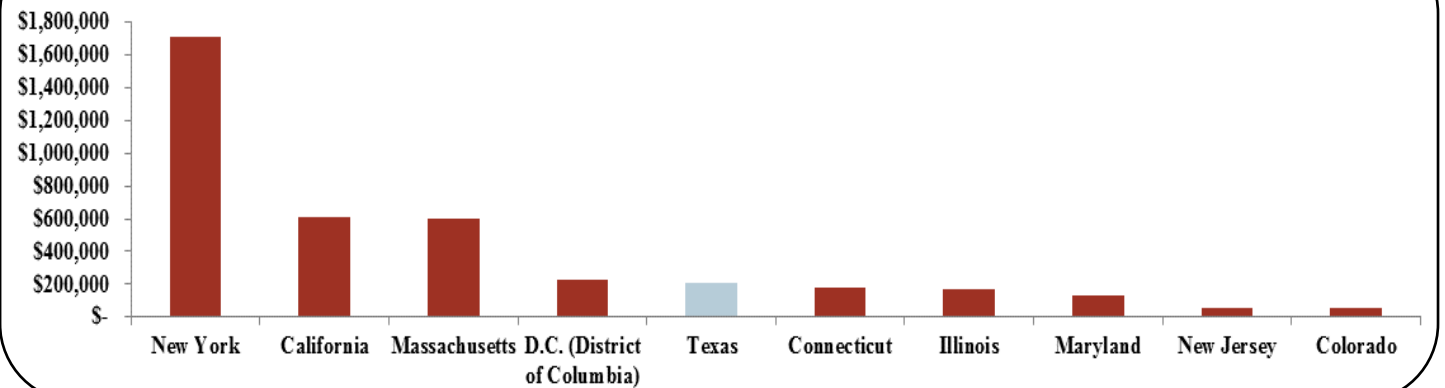
Exited PE & VC Deals in TX (LTM)

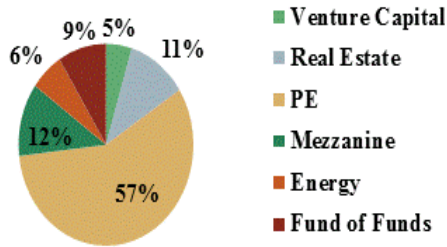

US States PE Activity by Deal Value

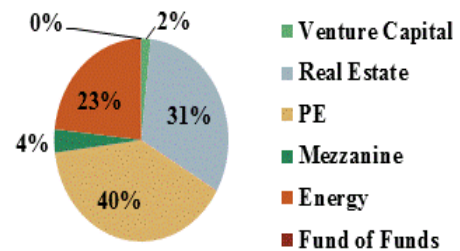

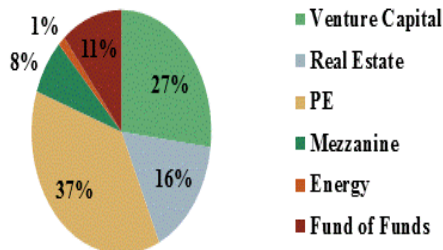
Capital Raised by US Funds



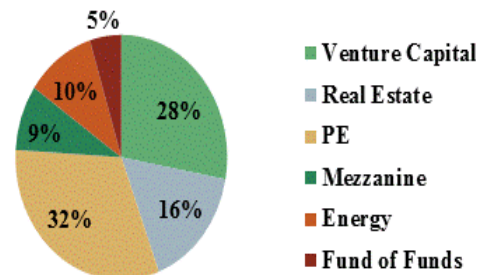
Capital Raised by Texas Funds
